## **Terms and Conditions of Service**

**1.** Prior to the stud service, the bitch owner will provide the following information to the stud owner:

Negative brucellosis test dated within 3 months
Copy of AKC pedigree
Copy of normal OFA Hip Report
Copy of normal OFA Elbow Report
Copy of CNM Report (or clear by parentage)
Copy of EIC Report (or clear by parentage)
Copy of board certified ophthalmologist's CERF Report
Copy of up to date vaccine records

**2.** The stud owner will not be liable for injuries that may be sustained by bitch during the breeding process or while on stud owner's property.

**3.** The bitch owner agrees to perform progesterone and/ or LH testing on bitch to determine proper breeding window. The bitch owner will be responsible for any and all medical expenses, including those pertaining to hormone testing and veterinary fees. If natural breeding cannot be accomplished, the bitch owner agrees to cover costs involved in the collection and insemination by veterinarians.

**4.** Any or all of the following breeding methods may be used, by agreement of both parties and with payment of all costs and charges for such methods as described below.

<u>A.</u> **Natural Breeding:** The stud fee is \$1500.00 or pick of the litter at the stud owner's option. The natural breeding constitutes either one or two natural tie breedings as determined by proper breeding window. A payment of 20% of the fee will be paid at the time of breeding. The breeding fee is non-refundable, except in the event the stud owner selects "pick of the litter" option.

If the bitch does not conceive on the first service, one additional service will be provided within the next 18 months, at the bitch owner's option. In such event, the charge for the additional service shall be the then- existing stud fee, less the 20% non-refundable fee previously paid.

<u>B.</u> **Fresh Chilled:** The stud fee is \$1500.00. A payment of 20% of the fee must be received by the stud owner prior to the shipment of fresh chilled semen, and is non-refundable.

The stud fee is \$1500.00. A payment of 50% of the fee must be received by the stud owner prior to the release of the semen from the bank, and is non-refundable. The bitch owner assumes all risks whatsoever as to the semen at the time the semen is released from the bank. All costs of shipping and handling will be paid directly to the semen bank by the bitch owner, who shall promptly pay all AI veterinary expenses, as a condition of this agreement. If the bitch does not conceive, no refunds will be made.

**5.** As to all breeding methods described in paragraph 4, the remainder of the stud fee is due within two (2) weeks after the whelping of the litter of at least three live puppies. If fewer than three live puppies are whelped, the stud fee will be adjusted to an amount equal to the 20% of the applicable stud fee per live puppy. The stud owner will sign the litter registration after receipt of full payment.

The bitch owner agrees that no puppy produced as a result of this breeding will be sold to a pet shop, agent or broker.

**6.** The stud owner is not obligated to sign an application for litter registration with the AKC, nor may such application be made unless and until all applicable terms and conditions of this agreement have been complied with in full.

**7.** If the bitch owner(s) fails to fulfill the conditions of this agreement, the bitch owner(s) will be responsible for all attorney fees, costs or expenses incurred by the stud owner to ensure compliance of this agreement.
